

After completing my Accounting and Finance degree at the National College of Ireland, I earned CAPI exemptions. Recently, I completed my FAEs with CAI. The support from colleagues and the Firm's dedication in offering plenty of resources eased the exam pressure. The varied client base from sole traders, charities to small multinational companies has provided me a wide range of experience and enabled me to engage with insightful professionals across various fields.
